Part of the Consideration shall be satisfied by the issue of the zero coupon convertible bonds for the principal amount of HK\$641,300,000 at the Conversion Price of HK\$0.6413. Upon full conversion, the Company will issue an aggregate of 1,000,000,000 new Shares.
