On 23 February 2013, the Company and Mr Ong Cheng Heang have entered into the Supplemental Agreement to amend certain terms and conditions of the Principal Acquisition Agreement dated 27 July 2007 pursuant to which an aggregate consideration of HK\$660,000,000 shall be payable upon Completion. Part of the Consideration shall be satisfied by the issue of the zero coupon convertible bonds for the principal amount of HK\$641,300,000 at the Conversion Price of HK\$0.6413. Upon full conversion, the Company will issue an aggregate of 1,000,000,000 new Shares.
